2. RCMB membership
3. Federal Aviation Administration (FAA) registration
4. Instructor Sign Off (if a Student Pilot)

**All Flying Members Must Also Be Members of The Academy of Model Aeronautics (A.M.A.)**

Types of Membership:

**Life Members** - Pay a onetime membership fee of \$650.00. This fee is not combinable with any previously paid amount but is separate and distinct and stands on its own. Life membership begins upon payment of the fee.

**Regular Members** - Annual Dues are \$65.00 plus an Initiation Fee of \$50.00 the first year. Members joining RCMB Between November 1 and April 1 will pay 1/2 years dues for the remainder of the current year. Regular Members: are at least 18 years of age and are entitled to all rights and privileges of club membership.

**Family Membership** - \$90.00 plus an Initiation fee of \$50.00 the first year. A Family membership covers the members spouse and all minors (Under 18 yrs.) in the Adult member's immediate family. Dues for subsequent years are \$90.00 for family membership. Only one family member may vote on Club business.

**Junior Members:** \$25.00 each year with no initiation fee. Junior Members are either less than 18 years of age or a full time college student under the age of 21. They must be sponsored by a senior or regular member. They are entitled to flying and voting privileges but are not allowed to hold any office.

**Associate Members:** Annual Dues are \$30.00 per year.

Associate members are entitled to all rights and privileges of club membership *except the right to fly at the club field and the right to vote. Associate members do not have to maintain A.M.A. Membership.*

**Late Payment Penalties:** *If Renewal Dues are paid after April 30th, but are paid before June 30<sup>th</sup> of the year due, a Late Payment fee of \$10.00 will be charged. Any member not paying Renewal Dues by June 30<sup>th</sup> will be considered a "NEW MEMBER" and will be expected to pay an initiation fee of \$50.00 in addition to their annual dues.*
